

TAREN POINT BEER PONG TERMS AND CONDITIONS 2019

DETAILS OF ENTRY

1. Information on how to enter and prizes form part of these Terms and Conditions of Entry.
2. Entry into the Taren Point Hotel 'Beer Pong' competition is available to people over the age of 18.

RULES OF COMPETITION - TIPPING COMPETITION

6. 3 Players Per Team
7. 10 Cups per side of the table, arranged in a triangle
8. Initial possession is determined by the toss of a coin
9. Each player on the team shoots once, 3 shots per end
10. If a ball goes into a cup, the cup is removed.
11. If the team makes all 3 shots in a row, they will get all balls back & shoot again. The team will continue until a shot is missed.
12. Cups must be re racked at 6, 3 and 1. A shot may not occur until the re rack has taken place.
13. As soon as one team eliminates all their opponents cups, they win the game.
14. Each match will be the determined by a best of 3 series. One team needs to will 2 games to progress to the next round.
15. Drinking while playing is up to the discretion of the players and isn't a mandatory part of the game.
